

Terms of Use

This page (the “Directory”) is made available by Match-Trade Technologies LLC (“we”, “us”, the “Company”). By viewing the Directory or using it to open an account with any broker or proprietary trading firm listed on it (each, a “Partner”), you accept the terms set out below. If you do not accept them, please do not use the Directory.

1. What the Company is

The Company provides trading platform technology and related software. The Company is not a broker, is not a proprietary trading firm, does not hold or control client funds, does not provide investment, financial, tax, or legal advice, and is not a party to any agreement you enter into with a Partner.

2. Eligibility

By using the Directory, you confirm that you are at least 18 years old (or the age of majority in your jurisdiction, if higher) and have full legal capacity to enter into these Terms. If you do not meet these requirements, you must not use the Directory.

3. The Directory is not a recommendation

Their inclusion does not constitute a recommendation, endorsement, approval, or verification by the Company of any Partner, its regulatory status, its products, or the quality of its services. We do not guarantee that any Partner is suitable for you, is authorised to provide services in your country of residence, or will continue to be listed in the future. You are solely responsible for conducting your own research and due diligence, including verifying a Partner's licensing and regulatory status, before opening an account or depositing funds.

4. Partners are independent third parties

Registration, identity verification, and account opening take place entirely on the Partner's website and are governed exclusively by the Partner's own terms and conditions and privacy policy. Any information you submit as part of that process including your name, contact details, identification documents, and password is sent directly to the Partner. This website does not receive, store, or have access to that information.

6. No investment advice; risk warning
